## Foreword

### Eric Bulmer Chairman of Wardens



One of the tasks of an outgoing Chairman of the Wardens is to look back at the previous year and provide an overview of events and related issues for the benefit of the membership.

2019 was a very challenging year for the Freeman

The use of the Sands to accommodate the new County Council Headquarters has been a major issue throughout the year and the Freeman's determined opposition to the council plans has been clearly set out on our website. Unfortunately our endeavours were unsuccessful and planning consent was granted. Further details can be found in the Chairman of the Trustees report within the booklet.

The continuing difficulty in attracting members to step forward as Wardens and take an active involvement in the management of our organisation, has been a constant concern since I accepted the role of chairman in 2015.

My 3 year tenure of appointment as Chairman of the Wardens was completed in 2018, but unfortunately none of the present Wardens felt able to take on board the role of chairman. To address the impasse, I agreed to remain chairman for a further year so that a strategy could be developed that would ensure the sustainability of the management of the Freeman.

The Wardens addressed the issue by asking the membership to support their strategy to sustain the effective management of the Freeman. This was achieved when members voted overwhelmingly in November to accept the proposed Sustainability Paper and endorsed the wardens approach in dealing with this extremely difficult situation.

I subsequently stood down as Chairman of the Wardens on the 3<sup>rd</sup> of December.

As a consequence of the implementation of the Warden's strategy, a number of members have since indicated that they wish to be involved. This places the organisation in a much better position to deal with a challenging future that lies ahead. From this group, it is envisaged that we will be able to appoint Deputy Wardens, thereby expanding the management team and sharing the workload. Further information regarding Deputy Wardens can be found within the booklet.

A number of changes in management took place in 2019. Bob Elliott resigned as Warden of the Masons Company and Membership Secretary and Joe McElwee resigned as Warden of the Cordwainers' Company. On behalf of the Wardens I would wish to take this opportunity to thank them both for their past service to the Freemen.

I am pleased to report that Alan Metcalf was elected as the new Warden of the Cordwainers' Company. A profile of Alan can be found later in the booklet. Iain Wilmshurst agreed to continue as a Warden of the Curriers' Company and was re-elected unopposed.

The Annual Dinner was a great success even accounting for a last minute change of venue to the Masonic Hall. My thanks to the Wardens and particularly John Booth for responding so positively under extremely difficult circumstances.

During the year we welcomed 6 new Freemen into our ranks and the current membership now stands at 251.

Alan started his working life as an apprentice motor mechanic in the Adams and Gibbon garage in Claypath in 1973. After successfully completing three years training he later went on to work in garages in Langley Moor, Sherburn Village, Esh Winning and Crook before setting up his own taxi business. He left after nearly a decade to take up a job with the National Car Parks in Durham in 2001.

Two years later he was appointed the organisation's supervisor in Sunderland and then their North of England Training Officer, the job also embracing parts of Lancashire, Scotland and Northern Ireland.

## New Members Admitted in 2019

**Candlemas Guild Day 4th February 2019**

The 62-year-old grandfather's walk, of a little more than 100 yards from his current workplace in Clayport to the Town Hall, completed the circle in a long working life that started as an apprentice motor mechanic just a few yards further away in the Adams and Gibbon garage in Claypath in 1973.

For most of his working life Norman worked as a solicitor in the city, not a stones throw from the Guild Hall. During his long legal career, he was for more than a decade, the city's Deputy Coroner,

Norman resigned recently as a trustee of the Freemen, and for the last two years he held the office of chairman.

He was vice-chairman of Finchale Training College for many years and a trustee of the Durham Union Society. He also sat as a member of two health service trusts and the Abbeyfield Society and remains a Rotarian in the city.

Gardening remains his key leisure activity after he surrendered his interest in motoring racing when he sold his rare 1936 MG which he drove, when occasion allowed, at Brooklands and Croft. The car had appeared at the Goodwood Festival and featured on television in one of the Father Brown Series.

After leaving the Durham Johnston Grammar School in 1963 with three A-levels, he was articled to a large firm of chartered accounts on Tyneside until he qualified four years later. In the early 1970s he took charge of his own company in Durham, operating for many years from offices in Saddler Street.

When he became a trustee of the Freemen, Alan's experience was immediately called on to steer the organisation through new Charity Act regulations to qualify for charitable status – a move which significantly increased the freemen's ability to offer financial support to a wide range of organisations across the city.

Alan resigned recently after serving as a trustee but continues to support the organisation as a member of the Freemen's Charitable Trust. The Freemen have benefited from his expertise in accountancy for many years and continue to do so.

For 30 years Alan was District Treasurer of the Durham Scouts, the Durham Citizens Advice Bureau and a Director of the Indoor Market where he remains Company Secretary. For more than two decades he has been Treasurer of the Shakespeare Temperance Trust in North Road and a Trustee and Honorary Treasurer for Durham Rotary Club. He has also been a long-standing Trustee of Durham Union Society and member of the Finance Committee of the Governors of Northumbria University.

Alan remains a member of the Mayor's Bodyguard.

George started work as an indentured trainee journalist in the city in the mid-1960s and over the years his work has been widely published in regional and national newspapers. He has been a contributor to both regional radio and television and was also involved in the BBC's expansion of the local radio network in the late 60s, producing broadcast material and interviews for Radio Durham – the experimental forerunner of current stations on Tyneside, Teesside and Cumbria.

In 1986 he was directly commissioned into the Light Infantry and was one of the first journalists recruited by an expanding part-time specialist unit, now known as the Army's Media Operations Group. Assignments took him across the UK and mainland Europe until he left the Army ten years later.

For 17 years, until his retirement in 2009, he managed Durham Constabulary's Press and Public Relations unit and received unsolicited awards from north-east journalists and a commendation from Durham's Chief Constable.

Although George recently resigned as a trustee where he held the post of official Freemen Press Officer, he continues to offer his valued expertise and support to the Freemen which is very much appreciated,

In retirement George continues to pursue a life-long interest in fishing for trout, sea trout and salmon.

Following a family tradition Alex and James were honoured to be admitted as Freemen.

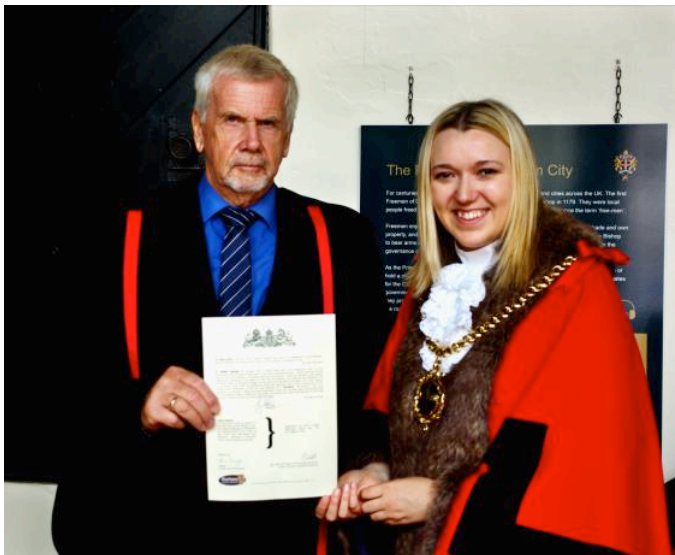
Alex and James were born in Dorset and were pupils at Ballard School in New Milton and then at Canford School in Wimborne.

Alex studied History at Birmingham University and is now studying for his Law exams at the University of Law in Guildford, while James took a different path studying management at Warwick University, qualifying as a chartered accountant and now lives in London. When he is not working Alex enjoys music and running, while James pursues several interests including cooking and sport, where he enjoys playing football for his university team.

The family's membership of the Drapers Guild has been passed on for many generations. They have the Admission Certificates going back for five generations to their three times great grandfather Williams Lee who was admitted in 1831 and research shows that they can trace their family back to their eight times great grandfather Roger Lee who was admitted to the Drapers Guild in 1705. It appears many of those admissions took place in the same Guildhall James and Alex's ceremony.

It is possible that the Freemen in their family go back beyond that time and indeed their family folk lore, is that they became Freemen due to an ancestor fighting in the Battle of Neville Cross in 1346.

## Deputy Wardens Initiative

In a continuing drive towards the sustainability of the Freeman through the involvement of members to support the management of the organisation, the Wardens have decided to introduce the category of 'Deputy Warden' into the management structure of the Freeman.

This strategy is designed to enable Freeman to be targeted, who have the skills, interests and desire, to take an active role in the management and development of the Freeman.

The Important feature of this strategy, is that individuals will be 'targeted' in contrast to the elected position of Warden.

The aims and benefits of this initiative are two-fold;

1. Strengthening and sustaining the management group.
  - a) To increase the numbers within the management team, so that the increasing workload can be shared.
  - b) To enable Wardens to have the support of a another member from their Company, who will deputise when they are unable to attend meetings/ functions.
  - c) To bring fresh ideas, stimulus and skills to support the management team.
2. Engagement and involvement with the membership.

To provide members with an opportunity to witness the management of their organisation and garner experience that will ultimately result in them wishing to apply to become a Warden in due course.

All members within travelling distance to the city of Durham will invited to an induction evening to gather more information about the introduction of Deputy Wardens, this will enable them to decide whether they wish to put their names forward to become part of the management group.

Any member unable to attend the meeting, can still register their interest by contacting our Secretary Kathleen Vasey.

## Membership Criteria

Any man or woman who has attained the age of 18 years and has any of the qualifications set out below is eligible for consideration for admission to the Freemen of the City of Durham. The qualifications for eligibility for Freedom of the City of Durham are:

### **1. Guild Servitude**

Completed service in an apprenticeship of at least three years duration in a recognised trade, or equivalent trained employment status deemed satisfactory to the Wardens of the Durham City Freemen with an employer who is a Freeman of the City of Durham.

### **2. Durham Servitude**

Completed service in an apprenticeship of at least three years duration in a recognised trade, or equivalent trained employment status deemed satisfactory to the Wardens of the Durham City Freemen, in one or more trades within the Durham City boundary.

### **3. Hereditary Freedom**

He or she is the son or daughter of a Freeman of the City of Durham.

### **Customary Freedom**

Men and women who have attained the age of 18 years who are not otherwise qualified in accordance with 1.2.3. above, may be admitted as Freemen in accordance with ancient local custom or practice subject to the approval of the Wardens.

All claims to Freedom of the City should be supported by sufficient documentary evidence of entitlement to be submitted for consideration by the Wardens of the Guilds meeting collectively. Following due consideration, the decision of the Wardens in respect of any claim to Freedom of the City shall be final.

Honorary Freedom conferred by the former Durham City Council or by Durham County Council is distinct and separate from the Freedom granted through the eligibility outlined above and the approval of the Wardens. The rights, duties and powers of the Durham City Freemen shall continue in accordance with the provisions of the Durham City Council Act 1985 and associated customary practice.

## **Customary Freedom**

*Appended - Note of Clarification (July 2019)*

These discretionary awards, generally fall into the following three categories (a) (b) (c).

- a)** Personal applications by individuals who do not qualify to be admitted under 1,2, and 3 above, but who can provide evidence of craft servitude or a link with the Freeman through hereditary, ( sometimes called patrimony) e.g. via grandfather etc , where a direct route via a parent is not possible.
- b)** Individuals identified by the Wardens who can make a significant contribution by undertaking a specific role/need within the management structure and having personal qualities of integrity, tolerance, and judgment and who are able to demonstrate experience or support relevant to the Freeman's activities, together with one or more of the following;
  - A desire and capacity to devote time to the activities of the Freeman.
  - Existing or previous involvement in public or charitable service.
  - Success in their chosen profession or career.

Gentleman and Lady Freeman is an award conferred on individuals, in recognition of a significant contribution they have already made in supporting the work of the Freeman.

*An important point to note is that categories (b) and (c) are by invitation only and will not be available upon application. Category b) will only be exercised when the Wardens believe there are areas within the current management function that may not be sustainable and may cause its future development to be blighted. It is anticipated that the number of Freeman admitted via this process will be limited to only a few in number.*

Amendments will not be made retrospectively.
- 1.3 We will always comply with the General Data Protection Regulation(GDPR) when dealing with your personal data. Further details on the GDPR can be found at the website for the Information Commissioner ([www.ico.gov.uk](http://www.ico.gov.uk)) For the purposes of the GDPR we will be the 'controller' of all personal data we hold about you.

<b>Legal Basis for Processing</b>	For the legitimate purpose confirming the criteria for Membership.
<b>Type of information</b>	Name, address, telephone numbers and

<b>Purposes</b>	Information published on the Freeman's website, in yearbooks And other publications in the Freeman's marketing materials.
<b>Legal Basis for Processing</b>	For the purposes of our legitimate interests in operating and Promoting the Freeman.

### **3. How we protect your personal data**

- 3.1 We will not transfer your personal data outside the EU without your consent.
- 3.2 We have established generally accepted standards of technology and operational security in order to protect personal data from loss, misuse or unauthorised alteration or destruction.
- 3.3 Please note however that where you are transmitting information to us over the internet this can never be 100% secure.
- 3.4 We will notify you promptly in the event of any breach of your personal data which might expose you to serious risk.

### **4. Who has access to the information you provide us**

- 4.1 We will never sell your personal data. We will not share your personal data with any third party without your prior consent (which you are free to withhold) except where we are required to do so by law or as set out in 2. above or paragraph 4.2 below.
- 4.2 We may pass your personal data to third parties who are service providers, agents and subcontractors to us for the purposes of completing tasks and providing services to you or on our behalf (e.g. to print newsletters and send you mailings). We do this for the purpose of our legitimate interests in operating the Freeman. However, we disclose only personal data that is necessary for the third party to deliver the service and we have a contract in place that requires them to keep your information secure and not to use it for their own purposes. It is possible

that third parties may themselves engage others (sub-processors) to process your data. Where this is the case third parties will be required to have contractual arrangements with their own sub-processor(s) that ensure your information is kept secure and not used for their own purposes.

## **5. How long do we keep your information**

- 5.1 We will hold your personal data on our systems for as long as you are a Freeman and for as long afterwards as it is in our legitimate interest to do so or for as is necessary to comply with our legal obligations. We will review your personal data every year to establish whether we are still entitled to process it. If we decide that we are not entitled to do so, we will stop processing your personal data except that we will retain your personal data in an archived form in order to be able to comply with future legal obligations and the establishment or defence of legal claims.

## **6. Your rights**

- 6.1 You have rights under the GDPR:
- (a) to access your personal data
  - (b) to be provided with information about how your personal data is processed
  - (c) to have your data corrected
  - (d) to have your personal data erased in certain circumstances
  - (e) to object or restrict how your personal data is processed
  - (f) to have your personal data transferred to yourself or to another organisation in certain circumstances.

*Died 8th September 2019*



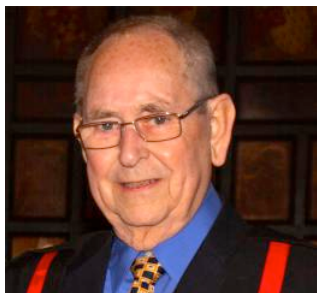
Beverly Renwick made history when she became one of the first women to be admitted as a city Freeman in February 2012– ending a 700-year-old men-only tradition.

### **Arthur Stonebridge - Barbers' Company**

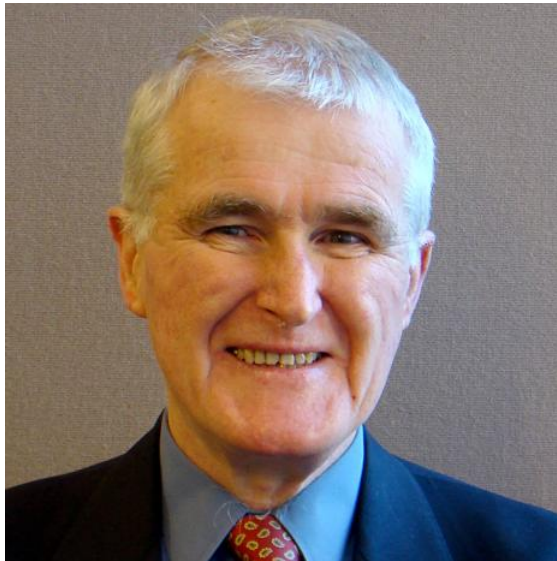
*Died 17th February 2019*

Arthur Stonebridge a Framwellgate Moor lad was an apprentice with Billy Fenwick who had a painting and decorating firm based in Crossgate. Arthur developed into a very skilled decorative craftsman , specialising in signwork and heraldry.

He went on to become an acknowledged expert in heraldry not only in Durham but extended his expertise beyond the county.

He will be remembered for his encyclopedic knowledge of the history of the county families of Durham.

## Chair of the Trustees Report



Twelve months ago, I suggested 2018 had been an eventful year. It is probably fair to say 2019 has been challenging for trustees, as they have sought to fulfil their primary responsibility of safeguarding the Freeman's assets.

During 2018, as reported last year, Kier Developments had submitted a planning application for the construction of a new civic headquarters on the Sands, which aroused considerable public comment and led to over 1000 written objections. Though no longer the landowner, the Freeman have an historic interest in the Sands and retain certain rights of common and herbage.

A working group of trustees examined the application in detail, had discussions with the developers and County Council officers, and following careful consideration, Durham City Freeman formally objected to the proposal. In our judgement the application contravened several matters in National Policy Planning Guidance and a number of saved policies in the Durham City Local Plan.

The planning application was considered by Durham County Council's planning committee in March 2019 and on behalf of the Freeman I addressed that meeting. The application was approved subject to referral to the Secretary of State.

Subsequently, the Freeman requested, as did other organisations, that the Secretary of State should call in the application and place it with an independent inspector. This request was refused.

Later in the year, Durham Council made application to deregister an area of common land (the former coach park), adjacent to the new civic headquarters, now being constructed and provide replacement land east of the Rivergreen Centre. Following further consideration, it was agreed to oppose this deregistration. Discussions are ongoing with the City of Durham Parish Council, who are also objecting, having regard to the public interest as regards accessibility and distance of the proposed replacement land from the Sands. At the time of writing a decision is awaited from the Planning Inspectorate.

Trustees work closely with the Wardens supporting their operational and development work, and when appropriate acting as a critical friend.

In recent years the Freeman have become increasingly proactive in the community, establishing apprenticeships, involvement with civic occasions, promoting local history, providing grant aid to community organisations through our charitable arm and developing links with other Freeman bodies throughout England and Wales.

You will read of this work elsewhere in the yearbook, which is in addition to the Wardens key responsibilities for maintaining the register of Freeman and organising the admission of new Freeman and Freewomen in accordance with statutory provisions

Sustainability in essentially voluntary organisations is always a challenge. During the year trustees offered advice and support to the Wardens as they deliberated this important topic. At their request I chaired a consultation with Freeman and later, together with the vice chair and clerk and recorder, oversaw a ballot of admitted Freeman on the Warden's proposal.

Centuries old institutions remain of relevance through their ability to accommodate change while being respectful of tradition. As with our predecessors, that continues to be a focus for Trustees, Wardens and admitted Freeman

## Treasurers Report



Twelve months ago, I was reporting on a roller coaster year. Financially, this has continued through 2019, though not always as expected.

The debate over the relocation of the Durham County Headquarters has not abated, though it has broadened considerably. The need to hold liquid funds remained constant and we remain so for the foreseeable future.

Our investment portfolio has been impacted by market changes around the world as we maintain an actively managed and diverse book of investments. The let up in the US/China trade war was welcomed around the world, even though it is only provisional. Towards the end of the year there was clarity over Brexit with a working majority in government.

Our portfolio grew by 13.3% as growth funds replaced income bonds. As I write the expected income yield for 2020 is 2.52%, plus an expected sustained upward movement in growth across the board.

The Freeman will continue to support local charitable and skill-based initiatives through the charitable trust and all returns and reports to the Charity Commission are up to date.

The defibrillator, which has an outer covering that displays the Freeman's logo, will be situated in the Marketplace.

It is anticipated that the equipment will be in place by Easter 2020.

## Remembrance Parade (£500)

Once again the Charitable Trust has granted £500 towards the mounting of the Remembrance Parade in the City. 8 Wardens and 8 Freeman represented our organisation as part of this year's civic procession.

A cheque was presented to Arthur Lockyear (representing the Advisory Group of the Durham City Remembrance Parade) at the Annual Dinner.



## Age UK



A grant of £250 was awarded Age UK, to support the development of a new Community Shed initiative in Belmont. It provides a local hub for people of all ages to take part in practical activities, including furniture upcycling, craft and woodcraft.

## Hawthorn House



Hawthorn House provides respite care for people over the age of 16 with complex health needs and behavioural problems, which is a vital support for their families who care for them at home.

The Charitable Trust granted £250 to the 'Amenity Fund' of a group of volunteers, that will enable them to purchase accessories including pictures posters etc to create an environment that is both stimulating and relaxing.

During our visit when we presented the cheque, we were impressed by the dedication of the staff, in creating a wonderful friendly environment for some of the most vulnerable members of our community

## St Margaret's Centre

The centre supports attendees recovering from mental illness. The numbers attending at St Margaret's Centre, a former school in the city's Margery Lane, has more than doubled in the past three years. As a result of increasing demand for their services, managers want to install a computerised database at a cost of £2500.

The Charitable Trust granted £500 towards the purchase cost of the equipment.

The 'Trust' are aware that the quality of the therapy delivered by staff and volunteers is outstanding and had no hesitation in offering our continuing support.



## **Solan Connor Fawcett Family Trust (registered charity)**



The charity was set up by Mark Solan following the death of his mother. As a result of the impact on his family he decided to set up the charity in 2015 to support local families, where a bereavement from cancer has occurred.

The charity supports families in a variety of ways including financial support through assisting with household bills etc.

The 'Trust' are pleased to support this amazing charity, developed and driven by the tremendous enthusiasm of Mark and his volunteers.
