#### A Brief History of the Barber Surgeons

From as early as 1000 AD, the role of surgeons and physicians was separated. The surgeons often catering to the lower class, while physicians resided in courts and castles and were to be found almost exclusively in the service of the wealthy. They considered themselves above the practice of surgery and instead observed the patients, spotting symptoms, injuries, and afflictions, offering counsel reliant upon their academic knowledge to suggest an appropriate course of treatment.

In 1308, King Edward II of England granted the barbers guild status created to regulate the trade of barbering in the UK. Afterwards, in 1375, this guild was further established and separated into two distinct roles – those who did surgery and those who were only barbers. In 1540 Henry VIII merged the barbers guild and surgeons guild to form the Guild of Barber Surgeons.

The physicians, mostly in the 15th century and onwards, were accredited and licensed by the universities in which they studied, whilst barber surgeons were not. They had to apply to the trade guild and would subsequently become apprentices to barbers. Over time the term barber surgeon was born and the basic service of a barber gained many other tasks.

The union of the Barbers and Surgeons was never easy to manage and the relationship continued uneasily for 200 years. In 1745, at the request of the surgeons, a Bill was finally passed and the Surgeons left the Company forming what eventually became the Royal College of Surgeons of England.

# New Chairman of the Wardens

Alan became a Freeman in February 2019, admitted via Customary Freedom. He was elected Chairman of the Wardens in November and Secretary to the Charitable Trust in September of this year.

Alan started his working life as an apprentice motor mechanic at Adams and Gibbon garage in Claypath in 1973. After successfully completing five years training he went on to work in garages in Langley Moor, Sherburn Village, Esh Winning and Crook before setting up his own taxi business. He left after nearly a decade to take up a job with the National Car Parks in Durham in 2001.

Two years later he was appointed the organisation's supervisor in Sunderland and then their North of England Training Officer, the job also embracing parts of Lancashire, Scotland and Northern Ireland.

There then followed spells in a telephone call centre and a council CCTV centre in Chilton before he took up his latest post, offering face-to-face advice to members of the public on a range of issues including council tax and housing benefits.

Alan has an interest in men's mental health and in his spare time attends a support group in Spennymoor. He also has a keen eye for photography.

# New Warden of the Barbers' Company and Secretary to the Freemen

Brian was made a Freeman in February 2022. He was elected Warden of the Barbers Company and Secretary to the Freemen in October 2023.

He started work as an apprentice draughtsman in 1964 and further education led to an appointment as a junior engineer with the then City Council. He was promoted to senior engineer in 1972 and was made chief engineer in 1980, a post he held for eight years before becoming operations director, a position he held until his retirement in 2000.

One of the many projects in his career from which he takes particular pleasure was his involvement in the unique design of a footbridge over the A690 at the Gilesgate roundabout.

He created a scale model of the bridge, a task which formed an integral part of studies for an honours degree in civil engineering. To prove its safety credentials it was tested – quite literally – to destruction and the results subsequently scrutinised by the Institution of Civil Engineers earned him chartered member status.

# Warden of the Butchers' Company Re-Elected

After a three-year tenure of appointment Mac has been re-elected as Warden of the Butchers Company.

Mac, started his working life at Dawdon Colliery in 1960 and started work with Seaham Urban District Council in 1971. He then moved to Wear Valley then Durham City Council as Health and Safety Officer and become a Durham County Councillor in 2006 and was elected Chairman of the authority in 2010.

Mac was appointed a magistrate in Durham City in 1979, becoming chairman of the bench in 2001 before accepting the same role with the North Durham Bench two years later retiring in 2014 after 35 years service.

He became a member of the Durham Police Committee in 1988 and continued sitting when it became the Durham Police Authority, serving both for more than 15 years.

The Durham City Charter Trust has appointed Mac as Recorder, a position previously held by the Town Clerk, Clerk to the Justices, City Council Solicitor, and Monitoring Officer.

# Admission by Application.

Applicants should contact the Membership Secretary in the first instance.

Any man or woman who has attained the age of 18 years and has any of the qualifications set out below is eligible for consideration for admission to the Freemen of the City of Durham. The qualifications for eligibility for Freedom of the City of Durham are:

#### 1. Guild Servitude

Completed service in an apprenticeship of at least three years duration in a recognised trade, or equivalent trained employment status deemed satisfactory to the Wardens of the Durham City Freemen with an employer who is a Freeman of the City of Durham.

#### 2. Durham Servitude

Completed service in an apprenticeship of at least three years duration in a recognised trade, or equivalent trained employment status deemed satisfactory to the Wardens of the Durham City Freemen, in one or more trades within the Durham City boundary.

# 3. Hereditary Freedom

He or she is the son or daughter of a Freeman of the City of Durham.

# 4. Customary Freedom Admission by Invitation only.

This entry process is at the discretion of the Wardens, if the invitee is accepted this obviates the need for the first two calls as the Wardens represent their members.

Men and women who have attained the age of 18 years who are not otherwise qualified in accordance with 1.2.3. above, may be admitted as Freemen in accordance with ancient local custom or practice subject to the approval of the Wardens.

Before application forms are sent to Durham County Council Legal Department for approval, the application form must be completed and signed by the applicant, including the declaration form authorising Freemen monies to be used for charitable purposes.

# **Chair of the Trustees Report**

With great sadness I begin my report acknowledging the work of Stewart Atkin, treasurer to the Freemen of Durham for many years. Stewart passed away at the end of August. His wise counsel, attention to detail and professional integrity ensured the finances of the Freemen are sound and thus enabled so many developments to have been progressed in recent years. His concise, though thorough



financial reports, delivered with a customary wry sense of humour will live long in the memory. Stewart was a true friend to the Freemen.

The condolences of the Freemen were conveyed to Christine and family, with trustees and wardens attending the funeral where Stewart's work in so many fields was acknowledged with thanks.

Stewart advised in January that he would be standing down as treasurer and trustee at the beginning of 2024. Therefore, the recruitment of a replacement began, and during the summer Scott Cooper, financial controller at Faltec Europe, was appointed as trustee with the intention of him taking over as treasurer following Stewart's resignation. Sadly that was effected sooner than we all had anticipated.

Senior trustee Malcolm Proud who has served the Freemen for over 30 years stood down as vice chair at the beginning of the year and relinquished his trusteeship in December 2023. Malcolm has provided the Freemen with invaluable continuity over three decades of significant social and economic change. The admission of women, establishment of the charitable arm and increased involvement in the civic and community life of Durham, have been just some features of Malcolm's tenure. For a number of years Malcolm supported Stewart Atkin in respect of financial management and acted as independent examiner of the accounts.

Alice Ambrose Thurman succeeded Malcolm as vice chair and in addition to Scott Cooper, Cathrin Morgan, head of statutory reporting for the Bernecia Group and holding a number of voluntary positions with the diocese, will be joining the trustees at the end of the year.

An eventful twelve months was also one of celebration, particularly the completion of the Freemen's Beacon, a gift to the City of Durham. In partnership with Durham County Council, it was installed on Jubilee Hill and first lit to mark the coronation of King Charles III. In similar vein the inaugural Apprenticeship Awards was a joyous celebration of achievements by young people.

More information on these events are covered elsewhere and I want to record my appreciation to John Booth and the wardens for so much hard work. John advised in September that he was standing down as chair of the wardens. His work and energy in that leadership role has transformed the profile of the Freemen.

The Freemen have played a central part over the centuries in the life of our city. In a rapidly changing world, with the future in many respects uncertain, continuity with previous generations becomes more important. Durham City Freemen are well placed to ensure history and tradition are respected while contributing to evolving circumstances.

In January I too informed trustees I would be standing down as chair and trustee at the end of 2023. It has been a pleasure and privilege to fulfil those roles and I am grateful to Roger Norris, a predecessor in this role for affording me the initial opportunity.

In conclusion I wish the Freemen of Durham, their trustees and wardens good fortune in their future endeavours.



# **Heraldry and the Guilds**

Project to Replicate Guild Shields - Eric Bulmer, Plumbers' Company

It is well known that heraldry, began in the 12<sup>th</sup> century on the shields of knights to identify them in the heat of battle, today heraldry provides devices for corporate bodies, local authorities and individuals.



#### Coat of Arms

The 'Shield' is a component of a Coat of Arms that also includes, crest, helm, wreath, mantling, supporters and moto.

These armorial devices on the shields of knights (e.g. swords etc.) were often replaced by emblems relating to individuals or organisations.

It was 100 years later before the London Guild of Drapers were granted a charter of incorporation by Henry VI, that enabled the granting of a Coat of Arms in 1438 by the Garter King of Arms, now known as the College of Arms.

It is unlikely that the Durham City Freemen were granted arms in their own right, but like other city guilds they would have copied and adapted those granted to the London Guilds.

# Heraldry of the Guilds'. - Durham Town Hall.

There is very little visible evidence of the Guilds of the Durham City Freemen within the Town Hall apart from;

1: Painted shields high in the roof structure of the Main Hall; examples below:







2. A small number of watercolour paintings of coats of arms of guilds in the Guildhall:

# **Objectives of the Project**

- 1. To replicate the shields of the original 16 Guilds (currently displayed in the roof structure of the Main Hall and placing them in the Guildhall (traditional home of the Guilds/ Freemen).
- 2. To enhance the environment in the Guildhall by displaying the shields to represent the history of the Freemen and under-pinning the origins of the craft and trade guilds.

# Progress of the project.

Tools and materials for painting the shields has changed little over 500 years, other than the improved quality the paint and refinement of the signwriting brushes. The application of gold and platinum leaf to an adhesive background has remained unchanged over the centuries and the metallic finish provides a gem like quality to the shield.

The stages of the process from wooden shield to completed shield, using enamel paint, gold and platinum leaf are set out below.
